ILLINOIS WILDLIFE BONUS PROGRAM

Landowners participating in USDA's Conservation Program (CRP) and Non – CRP can take advantage of Illinois Wildlife Bonus Program payments for completing wildlife friendly habitat practice such as:

Native Grass and Forb Plantings, Strip Disking, Invasive Specie Control, Legume and Forb Inter-Seeding, Strip Spraying and Prescribed Burn.

Before any project is started a completed application and plat map or aerial photo of the project area must be sent into QUGA. A 25% match for the total cost must be paid in advance by the landowner or your local QUGA Chapter.
